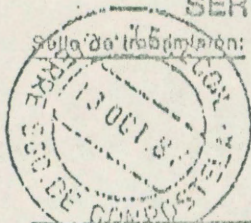

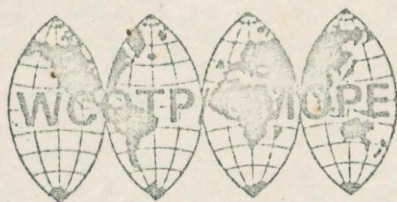

Subject: New Complaint, Brazil

Dear Mr Director General,

WCOTP has been informed that at the Universidade Santa Ursula in Rio de Janeiro, Brazil, 50 teachers have been dismissed. Of these, 38 are said to be dismissed for administrative reasons, but in 12 cases it is clearly stated that the dismissals were done for political (trade union) reasons as the teachers were involved in leading a strike.

Among the 12 is the First Vice President of the Associação Nacional dos Docentes do Ensino Superior (ANDES), Professor Sydney Solis, a leader of the local branch of ANDES at the university and a leader of the union in Rio de Janeiro. The latter one has already been reintegrated in his post as a local court decided that his dismissal was against the law on trade unions.

As these dismissals constitute a discrimination against trade union action and trade union leaders, I kindly ask you to submit this complaint to the ILO Committee on Freedom of Association.

Enclosed is a press cutting concerning the dismissals.
